VICTIMS' STORIES

Person A (19, female, 1st year university student)

Person T (13, male, 2nd year middle school student)

One day, Person A was walking around Shibuya station when someone

asked her, "Do you want to become a model?" Since he was very persistent, she decided to listen to what he had to say and followed him to an office. There, she had her student ID photocopied and a photo taken of her naked upper body. She was asked to sign a contract and desperately tried to refuse, but couldn't because she was surrounded by 10 adults. She was locked in a room and wasn't allowed to go home until she signed the contract. A few days later, they told her, "You got the job." In the four years since, Person A has been forced to appear in about 120 pornography videos.

Person T was sexually molested by a man who his brother in high school introduced him to. He felt disgusted and scared, but could not say that he hated it. That man was a member of an organization involved in child prostitution and produced and sold child pornography. It was found out later that he was videotaping the act of molesting Person T and selling it online. A report was made by a third party to Lighthouse, and the police intervened. Three people, including the man, were arrested, and Person T was able to escape from his situation.

WHAT WE DO

1. SUPPORTING VICTIMS

We provide direct support and consultation services to victims via toll-free multilingual hotline and emails. Since 2005, the year Lighthouse started its hotline, we have provided more than 4,000 consultations and direct support to more than 320 people.

2. TRAINING AND LECTURES

We train lawyers, government officials, immigration authorities, police officers, social workers, and teachers who have direct contact with potential victims. More than 29,000 people have taken our seminars and those participants have been able to identify victims and report to us.

3. RAISING AWARENESS

To protect from becoming a victim, we launch campaigns and projects that would enable more people to be aware of the issue. For example in 2015, we published a manga called "Blue Heart" in the hope of protecting children and youth from the commodification of sex in Japan.

4. ADVOCATING FOR POLICY

We believe that without any comprehensive anti-trafficking provisions, the problem of human trafficking will never be eliminated. Therefore, we are committed to lobbying the Japanese government to change the current legal system so that more victims of human trafficking can be recognized and can receive support.
